1. I HAVE DELGATED THE RESPONSIBILITY OF MY SHARE TO THE WADAAGSAN COMPANY L.L.C TO MANAGE AS PER THE COMPANY POLICY.
2. THE MINIMUM SHARE AMOUNT FOR SHARE "A" IS \$93,750.00 (NINETY THREE THOUSAND SEVEN HUNDRED FIFTY ONLY) EQUVALENT OF 750 SHARES. THIS SHALL BE THE CONSIDERATION.
3. THE SHAREHOLDERS IN CATEGORY "A" SHALL NOT TRANSFER THEIR SHARES TO ANOTHER PERSON WITHOUT THE WRITTEN CONSENT OF THE COMPANY.

6. THE SHAREHOLDER'S SHARE SHALL ALWAYS BE VALUED IN U.S. DOLLARS CURRENCY.
7. THE SHAREHOLDER'S INVESTMENT MONEY (LIQUIDATED) AND THE COMPANY'S GENERAL ASSET SHARE THE SAME FATE FOR PROFIT OR LOSS.
8. THE ANNUAL ACCOUNTS OF THE COMPANY SHALL BE DONE ONCE EVERY 12 MONTHS UPON THE COMPLETION OF THE SEAPORT PROJECT "THE PROJECT".
9. IN CASE OF ANY SHAREHOLDER DISPUTE, AS THE FIRST INCIDENCE, THE SAME SHALL BE REFRRED TO MEDIATION TO RESOLVE THE SAID DISPUTE. ON INSTANCE THAT THE DISPUTE IS NOT RESOLVED THEN THE DISPUTE RESLUTION PROCESSES UNDER ISLAMIC SHARIA LAW SHALL BE TO THE LOGICAL END.
10. THE SHAREHOLDER UNDER CATEGORY "A" (FOUNDER) IS CONSIDERED A PERSON WHO HAS INVESTED A MINIMUM OF \$93,750 (NINETY THREE THOUSAND SEVEN HUNDRED FIFTY ONLY) THIS SHAREHOLDER SHALL HAVE A SAY IN THE COMPANY'S DECISION MAKING. FOR THE SAKE OF CONFIDENTIALTY, ONLY SUCH A SHAREHOLDER SHALL BE ENTITLED TO ACCESS THE INFORMATION REGARDING HIS/HER SHARE IN THE COMPANY.
11. ANY SHAREHOLDER "A" WHO COMPROMISES THE COMPANY'S INTERESTS SHALL NOT BE ALLOWED TO PARTICIPATE IN THE COMPANY'S DECISION MAKING AND WILL BE SUBJECTED TO EVICTION PROCEDURES BY THE COMPANY
12. I DECLARE THAT I HAVE READ AND UNDERSTOOD, CONSENT, AND I HAVE SIGNED THE ABOVE LISTED COMPANY TERMS AND CONDITIONS, AND THEREFORE SHALL BE CONSTRUED TO BE A SHAREHOLDER "A" (FOUNDER).
